The Contest Sponsor is not responsible for lost, late, destroyed, incomplete, unreadable, corrupted, or misdirected entries; Internet malfunction; server unavailability; or computer malfunction.

Designs may not use the name or logo of the Santa Clara County Department of Behavioral Health Services or any other organization without the organization's express, written consent.

By participating in the contest, participants are bound by the decisions of the Contest Sponsor. The Contest Sponsor reserves the right to disqualify any submissions containing content deemed by the Contest Sponsor, in their sole and absolute discretion, to be obscene, offensive, or slanderous.

Any false information provided in connection with the contest by any participant may result in elimination of the entry from the contest.

Neither the contest entry submitted by me or my child, nor any portion thereof, infringes on any copyright, any rights of privacy or publicity of any person, or any other right of any third party.

The Contest Sponsor reserves the right to disqualify any entry that it believes infringes or violates the rights of any third party, does not comply with the Official Rules, or violates applicable federal, state or local laws. The Contest Sponsor may refuse to award any prize to a person who has violated any Contest Rule, gained an unfair advantage in participating in the contest, or obtained winner status using fraudulent means. The Contest Sponsor will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the contest and Contest Sponsor's decision concerning such disputes shall be final.

If the conduct or outcome of the contest is affected by human error, any mechanical, technical, electronic, communications, telephone, computer, hardware or software errors, malfunctions or failures of any kind, intentional interference or any event beyond the control of the Contest Sponsor, the Contest Sponsor reserves the right to terminate this contest, or make such other decisions regarding the outcome as the Contest Sponsor deems appropriate. All decisions made by the Contest Sponsor are deemed final. The Contest Sponsor may waive any of these rules in their sole discretion.

The Contest Sponsor reserves the right, in their sole discretion, to modify, withdraw, suspend, or terminate this contest at any time and for any reason without prior notice.

The Contest Sponsor shall have the right to take, duplicate, display, disseminate, publish, and otherwise use:

- the name, age, and/or municipality of residence of me or my child
- verbal and/or written statements of mine and/or my child
- photographs and/or digital images of me and/or my child
- video or audio recordings of me and/or my child
- writings and/or other creative works of mine or my child

(collectively, "Materials"), for documentary, promotional, educational, or other lawful purposes. This may include use of the Materials in any manner or medium that the Contest Sponsor deems appropriate, such as, but not limited to, radio broadcasts; newspapers and other publications; television or film releases; slides; videotape; and distribution over the Internet.

In addition to the foregoing, I grant the Contest Sponsor the right to edit, prepare derivative works of, modify, and otherwise make use of my or my child's contest entry for documentary, promotional, educational, or other lawful purposes and in any manner or medium that the Contest Sponsor deems appropriate.

I may rescind the consent provided in the two immediately preceding paragraphs regarding the Materials at any time if compliance with that request is not unreasonably burdensome to the County or unlawful. I also understand that rescission of my consent will not affect any uses of the Materials that have occurred before I notify the Contest Sponsor of my decision to rescind consent. I, and each of my respective heirs, successors, and assigns, waive, release, forever discharge and covenant not to make a claim against or sue the Contest Sponsor, or any of Contest Sponsor's employees, agents, officers, directors, representatives, successors or assigns (collectively, the "Hosts") for any claim, liability, loss, injury or damage arising out of, or in connection with the contest entry, TRUST Logo Design Contest, or use of the Materials as described above. I agree to indemnify and hold harmless the Hosts from and against any liabilities, losses, claims, injuries, damages, demands, costs (including, without limitation, reasonable attorneys' fees) and expenses arising out of or in connection with my or my child's participation in the Contest.
